## **Fee Agreement**

Holistic Urgent Care and Holistic Primary Care are both operated as a “fee for service” practice and payment is due at the time of service. The purpose of this agreement is to inform you of our fee schedule prior to services rendered. **Please be aware that many out of pocket medical expenses can be used as tax deductions.** Please keep your receipts if you plan to utilize tax deductions. We do not keep financial records of your visits.

Naturopathic Physicians are currently considered OUT OF NETWORK for all insurance companies. We are happy to submit electronic claims to your insurance company for any consultations or procedures performed in our clinic. In order to obtain any reimbursement, your insurance plan needs to include out of network coverage and you must have satisfied the out of network deductible (which is separate from the “in network” deductible).

Most diagnostic testing, including blood tests and medical imaging, is considered “IN NETWORK”. While every insurance policy is unique (even members of the same family may have different coverage), our experience has been that most health insurance companies will cover some portion of the bill for diagnostic testing. While we do our best to help you navigate through insurance coverage, it is ultimately the responsibility of the subscriber/patient to know which services are covered and which facilities are in their network.

### **Office Visits and Consults**

Scheduled Office Visits and Consultations are billed at a rate of \$200 per hour. Phone consultations are billed at the same rate as office visits. Therefore, the cost of your appointment may vary and is necessarily dependent on time and complexity.  
Urgent Care Visit Fee is \$150.

### **Electronic Communication**

While we very much encourage communication and we welcome patient correspondence via email or our patient portal, please be aware that the use of these services may also be billed at the same \$200 per hour rate as a consultation. While some inquiries are simple and straightforward, others contain detailed clinical questions that warrant a case review and thoughtful response. This can quickly become overwhelming. By nature, holistic medicine is a highly individualized and therefore time intensive. In an effort to manage time effectively and provide the best quality of care for our patients, you may be billed for making use of online communication. We appreciate your understanding and sensitivity to this request.

### **Cancellation Policy**

We require a 24 hour advance notice to cancel appointments. If you do not show up for a scheduled appointment you will be billed for the cost of that missed appointment.

**IV THERAPY**

The IV therapy fee already includes time spent with your clinician and you will not be billed twice. The following are the charges for IV's:

- Electrolyte IV - \$175
- Nutrient IV - \$200
- Vitamin C IV - \$250
- Ozone IV - \$175 (additional fee if combined with vitamin infusion)
- Curcumin or Quercetin Push - \$50/mL
- Chelation (Heavy Metals Testing/Removal) - \$75
- Glutathione (Detoxification) IV Push - \$90
- Iron Dextran IV - \$325
- Hydrogen Peroxide IV - \$275

**Menu of Procedures and Services:**

- Blood Draw - \$30
- Testosterone injection - \$25
- B12 Injection - \$25
- Iron Injection - \$75
- Therapeutic Phlebotomy - \$60
- Prolotherapy- \$250 per syringe
- Infrared Sauna- \$50 per 30 min session
- Ozone Sauna - \$75 per 30 min session
- Acupuncture - \$100 new patient, \$75 follow up
- Rectal Ozone Insufflation - \$60
- Vaccinations – prices vary according to market availability. Your physician will discuss the expected costs prior to administering the vaccine
- Ear Wax Removal - \$99
- Suture Removal - \$89
- Wounds requiring suture - \$129 (Dermabond \$90 per tube)
- Incision & Drainage or Wound Debridement - \$129
- Wart Cryotherapy - \$129
- Sports Physical - \$80
- Nebulizer/Breathing Treatment - \$90 per session

- Urinalysis - \$40 copay (additional costs for specimen submission to lab)
- Diabetes Monitoring (serum glucose and ketones) - \$70
- Rapid Strep Test - \$40
- Mononucleosis Test - \$50
- Influenza Test - \$45
- RSV Rapid Test - \$55
- TB Skin Test + Reading - \$75
